



COVID-19 RELEASE OF LIABILITY WAIVER

The undersigned, _____ (*Print first and last name*), acknowledges that novel coronavirus (COVID-19) infections have been confirmed throughout the United States. In accordance with the most recent guidance and protocols issued by the World Health Organization (WHO), the Centers for Disease Control and Prevention (CDC), for slowing the transmission of COVID-19 the undersigned hereby agrees, represents, and warrants that neither the undersigned shall attend in-person trainings or events of ART INTERNATIONAL TRAINING AND RESEARCH, INC. (ART INTERNATIONAL) within 14 days after (i) returning from highly impacted areas subject to a CDC Level 3 Travel Health Notice, (ii), exposure to any person returning from areas subject to the above, or (iii) exposure to any person who has a suspected or confirmed case of COVID-19. The CDC Travel Health Network is continuously updating this list and the undersigned agrees that they are aware of this list and the countries listed.

The undersigned hereby agrees, represents, and warrants that the undersigned will not attend Basic ART training held by ART INTERNATIONAL if symptoms of COVID-19 are currently present, or are suspected or diagnosed/confirmed case of COVID-19.

ART INTERNATIONAL has taken steps to implement recommended guidance and protocols issued by the Public Health Agencies for slowing the transmission of COVID-19, including, without limitation, the access/use restrictions set forth above.

The undersigned acknowledges and agrees that ART INTERNATIONAL may revise its procedures at any time based on updated recommended guidance and protocols issued by the aforementioned public health agencies and further agrees to comply with ART INTERNATIONAL's revised procedures prior to attending any in-person training or event.

The undersigned fully understands and appreciates both known and potential dangers of attending in-person public events and acknowledges that attendance thereof by the undersigned may, despite, ART INTERNATIONAL's reasonable efforts to mitigate such dangers, result in exposure to COVID-19, which could result in quarantine requirements, serious illness, disability, and/or death.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER ART INTERNATIONAL HOSTED EVENTS FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO, PARTICIPATING IN LIVE TRAININGS, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

THE UNDERSIGNED, ON HIS OR HER BEHALF HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE ART INTERNATIONAL, its directors, officers, employees, volunteers and agents from all liability to the undersigned and all personal representatives, assigns, heirs, and next of kin of the undersigned for any loss or damage, and any claim or demand on account of any property damage or any injury to, or an illness or the death of the undersigned (or any person who may contract COVID-19, directly or indirectly, from the undersigned) whether caused by the negligence, active or passive, of ART INTERNATIONAL or otherwise while the undersigned participates in any program affiliated with ART INTERNATIONAL.

The undersigned hereby agrees to indemnify and save and hold harmless ART INTERNATIONAL, its directors, officers, employees, volunteers and agents, and each of them, from any loss, liability, damages or costs they may incur, whether caused by the negligence, active or passive, or otherwise while the undersigned participates in any program affiliated with ART INTERNATIONAL.

The undersigned understands and agrees that ART INTERNATIONAL is not required to provide insurance to cover the undersigned in the event they suffer illness, injury, death, property loss, theft, or damage of any sort upon participating in any program affiliated with ART INTERNATIONAL.

I HAVE CAREFULLY READ AND VOLUNTARILY SIGN THIS ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT AND FURTHER AGREE THAT NO ORAL REPRESENTATIONS, STATEMENTS, OR INDUCEMENT APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE. I AM AWARE THAT BY AGREEING TO THIS AGREEMENT I AM GIVING UP VALUABLE LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES FROM ART INTERNATIONAL TRAINING AND RESEARCH, INC. INCLUDING, FOR THE AVOIDANCE OF DOUBT AND WITHOUT LIMITATION, EXPOSURE TO COVID-19 AT ANY ART INTERNATIONAL TRAINING EVENT OR PROGRAM AND ANY ILLNESS, INJURY OR DEATH RESULTING THEREFROM. I UNDERSTAND THAT THIS DOCUMENT IS A PROMISE NOT TO SUE AND A RELEASE AND INDEMNIFICATION FOR ALL CLAIMS.
